#### Part 1 – Introduction

The National Freight and Supply Chain Strategy – Western Australian Implementation Plan (Implementation Plan) outlines initial actions to achieve the outcomes of the *National Freight* and Supply Chain Strategy and supporting National Action Plan, and establishes the role the Transport and Infrastructure Council will play in achieving these outcomes.

The Implementation of the National Freight and Supply Chain Strategy and National Action Plan in Western Australia will also involve coordinated actions with Commonwealth, State and Local governments, transport, planning and roads authorities, business across the local transport and logistics industry, research sectors and the community.

The Implementation Plan outlines the initiatives on which the Department of Transport WA and the Department of Planning, Lands and Heritage WA will be seeking to engage and coordinate with others, rather than direct the actions of others, to achieve local outcomes and benefits for the WA freight industry and supply chains.

# Part 2 – Implementation Framework

#### National Freight and Supply Chain Strategy

The National Freight and Supply Chain Strategy is an Australia-wide strategy to manage freight growth and change over the next two decades. The Strategy sets an agenda for coordinated and well-planned government and industry actions across all freight modes for the next 20 years and beyond.

By implementing the Strategy, industry and governments can improve existing practices, create new opportunities for Australian businesses, consumers and producers, and keep each other to account.

#### National Action Plan

The National Action Plan sits alongside the National Freight and Supply Chain Strategy and details key actions to be delivered by government to achieve the goals of the Strategy. The Action Plan will be informed by priorities identified in Commonwealth, state and territory freight plans and policies. The National Freight and Supply Chain Strategy and National Action Plan form the basis of ongoing consultation with and investment by industry.

The National Action Plan outlines the following critical action areas for the next five years:

- 1. Smarter and targeted infrastructure investment.
- 2. Enable improved supply chain efficiency.
- 3. Better planning, coordination and regulation.

#### 4. Better freight location and performance data.

The National Action Plan focuses on these critical action areas as they are key elements of nationally integrated freight systems. The National Action Plan identifies 13 actions that will deliver across these critical action areas at a national level. The success of the Strategy rests on how these actions are implemented and reviewed, and identifying new priorities.

#### Jurisdictional Implementation Plans

Each jurisdiction will play a critical role in implementing the Strategy and agreed National Actions. To support the national plans, each jurisdiction was required to prepare a local jurisdictional implementation plan outlining the key initiatives.

This document presents Western Australia's current actions towards implementing the Strategy and National Action Plan. Some of the actions will provide the foundation for future longer-term implementation initiatives.

#### Governance and partnerships

Implementing the National Freight and Supply Chain Strategy requires a high degree of coordination and collaboration across all levels of government and active involvement of the freight industry to drive productivity and efficiency improvements in the freight sector. The implementation will be overseen by the Council of Australian Governments Transport and Infrastructure Council.

The Commonwealth Department of Infrastructure, Regional Development and Cities and the WA Department of Transport and the Department of Planning, Lands and Heritage will have an ongoing interest in the implementation of actions, and will liaise with other WA state government departments, local councils and freight industry bodies and operators as and when relevant.

## Part 3 – Local Implementation Arrangements Western Australia

In addition to the items identified in the *National Action Plan*, WA will continue to act through other plans and programs to address local freight and supply chain issues. The local actions and their alignment to the *National Freight and Supply Chain Strategy* and the *National Action Plan* are noted in the WA Jurisdictional Implementation Plan (Appendix 1).

The WA Implementation Plan was developed in consultation with WA state and local government and industry. Following the Transport and Infrastructure Council's endorsement and public release of the National Freight and Supply Chain Strategy and National Action Plan, the Department of Transport and Department of Planning, Lands and Heritage co-hosted an industry consultation workshop.

The Consultation Workshop was held in September 2019 in Perth and 40 representatives from a range of WA industry and government freight, transport, planning and logistics stakeholders across all transport modes were in attendance. Initiatives and actions identified through the workshop contributed to the formation of the WA Jurisdictional Implementation Plan and a reporting group was established to provide ongoing support in the monitoring of the WA Implementation plan.

The WA Implementation Actions are provided in Appendix 1.

### Part 4 – Monitoring and Reporting

Monitoring and evaluation will underpin reviews of the National Freight and Supply Chain Strategy and National Action Plan through providing information to the Transport and Infrastructure Council and stakeholders on how initiatives are progressing in delivering the outcomes of the critical action areas, as well as identifying gaps and opportunities for improvement.

A national monitoring and reporting framework is being developed to track the progress of the implementation of the *National Freight and Supply Chain Strategy*.

Governments will report to the Transport and Infrastructure Council at the end of each year on their progress in delivering the Strategy and Action Plan. Monitoring and reporting will provide opportunity for the stakeholders to identify emerging opportunities and new issues to be considered.

The National Freight and Supply Chain Strategy and National Action Plan and its Jurisdictional Implementation Plans will be formally reviewed every five years in consultation with industry. The review will consider the results of monitoring that has been undertaken as well as new and emerging challenges and opportunities. The five-yearly review will ensure currency is maintained and enable actions to be updated and new ones to be developed.

The ability to monitor the success of the National Freight and Supply Chain Strategy will rely heavily on the contribution and collaboration of stakeholders to collect, analyse and share data and information.

The Transport and Infrastructure Council will agree the terms of the five yearly reviews and respond to the reviews' findings.
